Title: Junior Leader

Supervisor(s): Works under the general and detailed supervision of the Camp Luther Leaders.

**SUMMARY**

Junior Leaders will learn the skills necessary to become a leader. A Junior Leader will assist the Leaders in organizing the games and daily activities, helping the Camp Luther participants when needed, and helping prepare for the activities each day. The Junior Leaders assist the Leaders and learn leadership and problem solving skills in a fast paced, recreational environment. (Must be going in to 7<sup>th</sup> grade or older)

**DUTIES AND TASKS**

**In-Service Training**

- Attends the in-service training session to learn program philosophy, rules and guidelines

- **Must give the leaders a weekly schedule so they know when you are there**
- **Must call in to office-224-9070 if you will not be in that day**
- **Must follow same discipline rule**
- **Track your hours on the Junior leader timesheets**
- **Get project materials ready and distributed**
- **Help leaders get kids quieted down during attendance, rule explanations, lunch, etc.**
- **Supervise and help officiate activities/games**
- **Set up games by going over rules and instructions**
- **Play the games if they need more help, but be responsible**
- **Assist the younger children with projects and activities**
- **Must be active-walking around supervising, not sitting and socializing**
- **Participate with the children throughout the day, this includes playing during free time, organized games, board games and projects**
- **Greet the children and parents as they arrive to drop off/pick up participants**
- **Help clean program space throughout the day**

\*You are not there as the disciplinarian or to be the “boss” of Camp Luther kids, that is the job of the leaders.

\*You must follow the same rules and discipline policy as the Camp Luther children, remember you are there to assist the leaders, not be more work for them.

- Likes helping with games-gym, board and cards; art projects; and other activities.
